Penridge School District Begins Search for New Superintendent of Schools

Applications Due On or Before March 12, 2018

February 16, 2018, Doylestown PA: The Bucks County Intermediate Unit (Bucks IU) has been selected to assist the Penridge School District, of Bucks County, PA, in identifying a new Superintendent of Schools. Utilizing a community survey, with over 1,300 responses, the District's Board of School Directors developed an outline of the characteristics and requirements for the position. Penridge is seeking an experienced, student-centered, highly qualified leader who will embrace, drive, and expand the vision and mission of the district to ensure Penridge's excellence in education for all students. The school district strives to provide all students with a well-rounded educational experience where they acquire the 21st century skills necessary for a successful future.

The school district includes 7 elementary schools (K-5 with 3,167 students), 3 middle schools (6-8 with 1,758 students) and 1 high school (9-12 with 2,313 students). The district employs approximately 490 teachers, 74 percent of which have advanced degrees, and approximately 445 additional staff members, including part-time personnel.

The candidate must be able to demonstrate instructional leadership, excellent communications skills, be dedicated to partnering with the community, and have experience in fiscal/business management. The position requires:

- PA Letter of Eligibility
- A demonstrated record of educational leadership
- Excellent academic credentials (Doctorate preferred)

- Strong management and financial skills
- Curriculum and instructional experience at all levels of education

Applications must be submitted on or before Monday, March 12, 2018 with the successful candidate to start on July 1, 2018.
